## INTRODUCED BY MAYOR AND COUNCIL AS A WHOLE

AN ORDINANCE AUTHORIZING THE
LEASE/PURCHASE OF 2019 FORD F550 4X4 LIFELINE
CUSTOM SUPERLINER AND 2019 FORD F550 4X4
LIFELINE CUSTOM SUPERLINER POWER COT,
THROUGH THE STATE OF OHIO, DEPARTMENT OF
ADMINISTRATIVE SERVICES, STATE PURCHASING
AND DECLARING AN EMERGENCY

WHEREAS, the Village of Oakwood has enrolled in the Cooperative Purchasing Program which allows it to participate in state contracts which the Department of Administrative Services, Office of State Purchasing, has entered into and the Office of Cooperative Purchasing has distributed for the purchase of supplies, services, equipment and other materials; and

**WHEREAS**, the Village of Oakwood is desirous of acquiring a 2019 Ford F550 4x4 Lifeline Custom Superliner and 2019 Ford F550 4x4 Lifeline Custom Superliner power cot; and

**WHEREAS**, pursuant to the provisions contained in Section 735.053 of the Ohio Revised Code, the Village of Oakwood deems it cost effective to said vehicle from the State of Ohio through its designated vendor;

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio that:

<u>SECTION 1</u>. The Mayor be and he is hereby authorized and directed, upon the approval of the Board of Control, to enter into a contract on behalf of the Village of Oakwood with the State of Ohio, Department of Administrative Services - State Purchasing, through its designated vendor(s), for the lease/purchase of the following:

**SECTION 2**. Council hereby authorizes the expenditure of an amount not to exceed \$259,767.00 to effectuate the provisions contained in Section 1 hereof. The Director of Finance be and is hereby authorized and directed to issue vouchers in the amounts and for the purposes as expressed in Section 1 hereof, said amounts to be charged to the Fund No. 217-1113-52120.

SECTION 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village, the reason for the emergency being that the same relates to the daily operation of a municipal department and the ability to provide safe and effective emergency medical services to the citizens of the Village, therefore, provided it receives two-thirds (¾) of the vote of all members of Council elected thereto, said Ordinance shall be in full force and effect immediately

upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
