**A RESOLUTION OF CONDOLENCES
TO THE FAMILY OF ALBERT R. HUNZIKER**

WHEREAS, Albert R. Hunziker, former Certified Building Official of the Village of Oakwood, passed away October 22, 2019 at the age of 81; and

WHEREAS, Albert was born on February 16, 1938 to the late Al M. and Nellie Hunziker in Chardon, Ohio; and

WHEREAS, he served in the U.S. Army during the Vietnam War conflict; and

WHEREAS, he and Irene were married 54 years and from the union, they had two children; Marc and Denise; and

WHEREAS, Al served as the Chief Building Official of Highland Heights and retired in 2018 after twenty-two years of service at the Village of Oakwood. He also served on the Chardon Planning and Zoning Board. Al was one of the few in his field to hold seven certifications as a CBO. He even received a distinguished award by the Ohio Board of Building Standards. His quest for continuing education, made him one of the best in his field and was well-known and respected by other CBO's throughout the state; and

WHEREAS, he was not only an employee of the Village of Oakwood, but he was a regular attendee at the Village Summer Concerts and when U.S. Service people were honored by the Mayor, Al always stood at attention, giving honor to fellow-servicemen and women. He truly felt the U.S. was the greatest nation on God's green earth, as the Mayor exclaimed; and

WHEREAS, simply known as "Al" to those who knew and loved him, he enjoyed golfing, fishing, boating, camping and traveling. He cruised the Caribbean Islands, Alaska, Europe, and other exotic places throughout the world and traveled to Myrtle Beach each year to play golf with his friends; Paul Grau, Ross Cirincione, and Fred (his friend of 60 years); and

WHEREAS, it has been the privilege of Mayor Gary Gottschalk of Oakwood Village, to have worked with Al for over 20 years while he served as Oakwood's Chief Building Official. He distinguished himself in that position by helping attract a steady stream of upscale businesses in technology, life science and medical research with their high payrolls and local income tax revenues which transformed Oakwood into a premier community; companies like ThermoFisher Scientific, ViewRay (Cancer R & D), HomeInstead Senior Care, Medical Service Company,

Oakwood Laboratories (Cancer R & D) and American Anatomic Pathology Services to name a few; and

WHEREAS, Al will now join his Myrtle Beach golfing buddy; former Oakwood Village Law Director; Paul Grau, in a celestial foursome with legendary golfer, Arnold Palmer and others, as they play in the more fertile golf courses in Heaven that surpass even Augusta National, the earthly home of the Masters Championship; and

WHEREAS, Albert R. Hunziker, leaves a legacy with his wife; Irene, his children; Marc Hunziker and Denise (John) Joaquin, his grandsons; Kyle, Max, Joseph and Daniel, and his friends; and


NOW THEREFORE LET IT BE RESOLVED THAT by the Village of Oakwood, County of Cuyahoga, and State of Ohio, that:




