INTRODUCED BY MAYOR AND COUNCIL AS A WHOLE

AN EMERGENCY ORDINANCE AUTHORIZING THE LEASE/PURCHASE OF A PICK-UP TRUCK FOR THE SERVICE DEPARTMENT OF THE VILLAGE AND AUTHORIZING THE FINANCING OF THIS LEASE WITH FIRST NATIONAL BANK

WHEREAS, the Village has a need to upgrade the Service Department's pick-up truck; and

WHEREAS, the Director of Finance has indicated that it will be the most cost effective for the Village to lease this vehicle with a nominal purchase option at the conclusion of the lease:

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio that:

SECTION 1. The Mayor be and is hereby authorized to enter a lease agreement for the leasing of the following vehicle:

SECTION 2. The Mayor be and is hereby authorized to enter into an agreement with First Merit Bank in the aggregate amount of \$38,500.00 to finance the leases as delineated in Section 1 hereof.

<u>SECTION 3</u>. Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof. The Director of Finance be and is hereby authorized and directed to issue vouchers in the amounts and for the purposes as expressed in Section 1 hereof, said amounts to be charged to the Funds as listed in Section 1 hereof.

SECTION 4. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village, the reason for the emergency being that the same relates to the daily operation of a municipal department, therefore, provided it receives two-thirds (2/3) of the vote of all members of Council elected thereto, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
