Her message when leaving was always the same; I better find them the way I left them when I come back; and

WHEREAS, although she was afraid of heights, Pearl loved to travel. Annually the family took a vacation packing everyone in a station wagon driving to Canada, the southern states, western states, and other places but, it was always by car; and

WHEREAS, when she did visit other countries and had to fly, her grown children would get her a ticket on the Concord to make the trip shorter. She was always thankful to be the first one off the plane; and

WHEREAS, living by the mantra of once a mother always a mother; she was insistent her grown children let her know what they were doing and if they were traveling to call home once they arrived. One time, when one of her children flew from France to New York City and she hadn't heard from them, she had her bags packed ready to take a plane to find them, even though she dreaded the flight. Nothing would stop her from taking care of her family; and

WHEREAS, in her spare time, she planted and cared for her flowers. She loved cooking for her family with some of the favorites being her fried chicken, homemade macaroni and cheese; and

WHEREAS, we are certain, Pearl is now heading for the celestial Cleveland Municipal Stadium where she will find her beloved Wilbert in the Cleveland Browns locker room engaged in some serious pinochle with his favorite players, Otto Graham, Lou Groza, Marion Motley, Bill Willis and Lenny Ford, where she can spoil her sweetheart for all eternity, with her signature chitlins, greens and black eyed peas followed by her scrumptious blackberry pie topped by a generous dollop of vanilla ice cream; and

WHEREAS, this strong, loving, caring Super Mom has left a legacy with her children; Arline Gant, Bernard Burks, Belinda Barnes, Darlene Harris, Keith Burks, Linda Burks and Lynne Bell, her fifteen grandchildren, her twenty great grandchildren, her great great grandchild, her special friend; Mrs. Ivory, her Aunt Naomi and many who loved and respected her; and
