
## ORDINANCE NO. 2019-07



## INTRODUCED BY MAYOR AND COUNCIL AS A WHOLE

## AN EMERGENCY ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO A CONTRACT WITH A & S ANIMAL CONTROL, FOR THE PROVISION OF ANIMAL CONTROL SERVICES WITHIN THE VILLAGE OF OAKWOOD

WHEREAS, animal control services are necessary to promote the health, safety and welfare of Village residents:

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio that:

SECTION 1. The Mayor be and he is hereby authorized to enter into a contract with A & S Animal Control, for the provision of animal control services within the Village of Oakwood a copy of which is attached hereto, expressly made a part hereof by reference and marked Exhibit "A".

SECTION 2. Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 1 hereof. The Director of Finance be and is hereby authorized and directed to issue vouchers in the amounts and for the purposes as expressed in Section 1 hereof and the attachment to this Ordinance, said amounts to be charged to the Animal Control Fund (#10111552150).

SECTION 3. That actions of this Council concerning and relating to the passage of this legislation were adopted in an open meeting of this Council and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public, in compliance with all legal requirements including Section 121.22 of the Ohio Revised Code.

SECTION 4. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village, the reason for the emergency being that the same relates to the daily operation of a municipal department, therefore, provided it receives two-thirds (¾) of the vote of all members of Council elected thereto, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
