AN ORDINANCE ADOPTING A NEW CREDIT CARD POLICY FOR THE VILLAGE AND DECLARING AN EMERGENCY.

WHEREAS, Substitute House Bill 312 (Sub. H.B. 312) went into effect on November 2, 2018; and

WHEREAS, Sub. H.B. 312 enacted Ohio Revised Code (O.R.C.) Section 9.21 to regulate the use of credit cards and debit cards by political subdivisions; and

WHEREAS, this Council wishes to ensure compliance with O.R.C. Section 9.21;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Oakwood, County of Cuyahoga and State of Ohio that:

SECTION 1. Council hereby adopts the Village of Oakwood Credit Card Policy attached hereto hereto and incorporated herein as Exhibit "A".

SECTION 2. Section 140.09(a) of the Codified Ordinances of the Village of Oakwood is hereby declared to be in conflict with the Policy enacted by this Ordinance and is hereby repealed.

SECTION 2: This Ordinance is hereby declared to be an emergency measure immediately necessary for the preservation of the public peace, health, safety and welfare of the inhabitants of the Village or Oakwood so as to bring the Village into compliance with State law on the use and management of Village credit cards and therefore this Ordinance shall take effect and be in force immediately upon its adoption and approval by the Mayor provided it receives at least five affirmative votes of the members of Council; otherwise, it shall take effect and be in force from and after the earliest period allowed by law.
