## RESOLUTION NO. 2019 - 26

## INTRODUCED BY MAYOR AND COUNCIL AS A WHOLE

A RESOLUTION AUTHORIZING THE MAYOR TO EXECUTE AN AMENDED AGREEMENT WITH B & B LAUNCH, INC., DOING BUSINESS AS HOME INSTEAD SENIOR CARE FOR THE PROVISION OF A JOB RETENTION TAX CREDIT AND **DECLARING AN EMERGENCY** 

WHEREAS, on October 29, 2008 and October 8, 2013, this Council authorized the Mayor to execute a Municipal Job Creation Income Tax Credit Agreement with B & B Launch, Inc., an Ohio corporation, doing business as Home Instead Senior Care, (hereinafter "Home Instead"); and

WHEREAS, Home Instead has requested from the Village of Oakwood that Agreement be amended to assist in the expansion of their operations within the Village; and

WHEREAS, R.C. Sec. 718.151 permits municipalities to grant job retention tax credits;

NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio that:

**SECTION 1.** The Mayor be and is hereby authorized to enter into Job Retention Tax Credit Agreement with Home Instead in the form substantially similar to the one attached hereto, expressly made a part hereof by reference, and marked Exhibit "A".

SECTION 2. The Finance Director be and is hereby authorized to transmit the foregoing Agreement to the appropriate agencies for application of the credit.

**SECTION 3**. This Resolution is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village, the reason for the emergency being that the same relates to the daily operation of a municipal department and the creation and retention of economic opportunities within the Village for which time is of the essence, therefore, provided it receives two-thirds (3) of the vote of all members of Council elected thereto, said Resolution shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
