A RESOLUTION OF CONDOLENCES TO THE
FAMILY OF DAVID ALLEN BOGUCKI

WHEREAS, lifelong Oakwood Village resident, David Allen Bogucki, passed away March 27, 2019 at the age of 67; and

WHEREAS, he was born September 20, 1951 in the Cleveland area to the late Joseph Bogucki and Virginia Zumock. He and his siblings; Dolly and Thomas, attended the Bedford City Schools where David graduated with the class of 1971; and

WHEREAS, David acquired his certification in advanced emergency medical technology for ambulance with IV therapy and defibrillation, fire inspector and operations level hazardous materials. He joined the Oakwood Fire Department July 2, 1977 with a passion to save lives; and

WHEREAS, he received several citations from the Village of Oakwood during his tenure. In October of 1989 he assisted in saving the life of an Oakwood resident using the newly purchased defibrillator and again, in September of 1990, he assisted in saving the life of Jim Kulesza when he came in contact with a high voltage power line while trimming trees. David used the defibrillator to restart Kulesca's heart; and

WHEREAS, on December 1, 1991, David was promoted by Chief James Schade to the position of Lieutenant; and

WHEREAS, he met his wife, Rita Schaeffer, an Oakwood Dispatcher, at a Fireman's appreciation dinner in October 1977 and the two were married December 1979. From the union, they had two daughters; Jennifer and Catherine; and

WHEREAS, David also enjoyed woodcraft and screen printing, both of which he did out of his residential shop. Many family and friends still enjoy the beautiful cabinetry and furniture he created. He even assisted his neighbors in building their garages; and

WHEREAS, he has left a hole in the heart of his loving wife, Rita, his daughters; Jennifer Bogucki and Catherine (Derrick) Simmons, his grandchildren; Castalia Koson and Xavier Simmons, his neighbors, friends and fellow Firefighters; and

NOW THEREFORE LET IT BE RESOLVED THAT by the Village of Oakwood, County of Cuyahoga, and State of Ohio, that:

SECTION 1. The Village Council and Mayor wish to express their most sincere condolences to the family of David Allen Bogucki and hope the fond memories of such a fine, caring person comforts them in their loss.
