WHEREAS, Oakwood resident, Jeannette Rose Hambrick-Joyner passed away April 2, 2019 at the age of 82; and

WHEREAS, born in Albany, Georgia on July 17, 1936 to the late Essie Mae Landers and Willie Ivory, she was raised with prayer, preaching and traveling evangelists, which shaped her into a woman of great faith; and

WHEREAS, shortly after arriving in Cleveland, her siblings, Thomas Leola, Marion (Cassie), and Leon were born. Although, Thomas and Leon preceded her in death; and

WHEREAS, after graduation from East Technical High School, Jeannette continued her education at Manpower Training Center then at Cuyahoga Community College; and

WHEREAS, in 1953 she met and fell in love with Raymond Hambrick (deceased). God blessed their union with the birth of Raymond, Jr., Norma Jean "Latifa", and Linda Darcel; and

WHEREAS, having lived through the riots of the 1960's, Jeannette decided then, she would display love, not hate. Then due to personal experiences, she became politically active in her neighborhood; and

WHEREAS, every day she studied the bible along with teaching neighborhood children about her Lord. In addition, she was active in the PTA, the City Mission, Salvation Army, Great Lakes Science Center and the Child Evangelism Fellowship; and

WHEREAS, her children were important to her and Jannette wanted the best she could provide, so she worked several jobs including; ironing and cleaning homes, Ford Motor Company, a "Tool and Die" company, a "Child Care" center and was a 24-year employee of the US Postal Service, where she served as Union Steward. After leaving the Post Office, she became a "live-in" Nanny; and

WHEREAS, while taking a walk, her childhood sweetheart, Edward Joyner, spotted her. They were inseparable thereafter, and married later that year, enjoying each other as they did in their teenage years. Tragically, in 1985, Ed passed away. Jeannette decided to live life as Ed would have liked, so she began traveling. Her most memorable trip was to Israel, touring Jerusalem and being baptized in the Jordan River; and

WHEREAS, as a member of the New Jerusalem Missionary Baptist Church, she served on the #2 Usher Board, was involved in Vacation Bible School conventions, Baptist Training Union, Moody Bible College and the Postal Prayer Band. In 2010 she joined the New Life Gospel Center. She also attended the Mt. Olive Missionary Baptist Church where her daughter, Latifa Norma was a Deaconess and her son-in-law, Kenneth Wilson was a Deacon; and

WHEREAS, Jeannette was known as a loving wife, mother and homemaker who had an engaging personality and a strong faith; and

WHEREAS, this woman of God leaves a legacy of a life well-lived with her children, Raymond Hambrick, Latifa "Norma" Hambrick-Wilson and Linda Hambrick-White; her sister, Marion "Cassie" Skinner; her grandchildren, Rachel, D'artanon, Ciera, Brandon, Juan, Leah, Nicole (David), Mario (Britany), Kevin (Amanda), Leslie, Vann Lawrence, Nakisha, Quincy (Michelle), Lukea, Kristy, Erica, Shakenna and Kevin; many great-grandchildren; nieces and nephews, Kevin, Cecelia, Sterling (Gloria), Shawn, Shukela (James), Martin (Sandra), Marnessa, Edmond (Charlotte), Vincent, Jamel, the Hambrick, Sizemore and Nowden families along with a host of other relatives, friends, her church family, and the 89th Street family and surrogate son, Curtis Ray; and
