ORDINANCE NO. 2019-42.

INTRODUCED BY MAYOR AND COUNCIL AS A WHOLE

AN EMERGENCY ORDINANCE AMENDING EXISTING SECTIONS 122.01, CRIMINAL ACTIVITY NUISANCES, 505.16, DANGEROUS AND VICIOUS DOGS, 505.161, DETERMINATION OF DANGEROUS OR VICIOUS DOGS, AND 505.17, REGISTRATION OF DANGEROUS OR VICIOUS DOGS, OF THE OAKWOOD VILLAGE CODIFIED ORDINANCES.

WHEREAS, Ohio courts have found unconstitutional some municipal ordinances relating to the regulation of dogs as in conflict with the Ohio Revised Code; and

WHEREAS, Oakwood Village wishes to ensure compliance with the State of Ohio Constitution;

NOW, THEREFORE, BE IT ORDAINED by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio that:

SECTION 1: Section 122.01, Criminal Activity Nuisances, which currently reads as follows:

122.01 CRIMINAL ACTIVITY NUISANCES.

(a) The following activities occurring on residential property, and engaged in by an owner, occupant or invitee of the owner or occupant of residential property, are hereby declared to be public nuisances:

(1) Any animal violations under Section 505.03 (Animals or Dogs Running at Large), Section 505.06 (Killing or Injuring Animals), Section 505.07 (Cruelty to Animals) Section 505.09 (Barking or Howling Dogs), Section 505.10 (Animal Bites), and Section 505.16 (Dangerous and Vicious Dogs), of the Codified Ordinances;

(2) Any disorderly conduct, disturbance of the peace or other violation of Chapter 509 of the Codified Ordinances;

(3) Any drug abuse violation under Chapter 513 of the Codified Ordinances;

(4) Any gambling violation under Chapter 517 of the Codified Ordinances;

(5) Any health, safety, or sanitation violation under Chapter 521 of the Codified Ordinances;

(6) Any obstruction of official business violation under Section 525.07 of the Codified Ordinances;

(7) Any alcohol violations under Chapter 529 of the Codified Ordinances;

(8) Any sex offenses under Section 533.07 (Public Indecency), Section 533.08 (Procuring), Section 533.09 (Soliciting), or Section 533.10 (Prostitution) of the Codified Ordinances;

(9) Any offense against another person under Section 537.03 (Assault), Section 537.04 (Negligent Assault), Section 537.05 (Aggravated Menacing), Section 537.06 (Menacing), Section 537.07 (Endangering Children), Section 537.12 (Misuse of 911), or Section 537.18 (Unruliness and Delinquency of a Child) of the Codified Ordinances;

(10) Any offense against property under Section 541.03 (Criminal Damaging or Endangering) or Section 541.04 (Criminal Mischief) of the Codified Ordinances;

(11) Any theft violation under Section 545.05 (Petty Theft), Section 545.08 (Unauthorized Use of Property), or Section 545.19 (Criminal Tools) of the Codified Ordinances;
