WHEREAS, he enjoyed dancing and listening to Motown music. The 'Temptations' and 'Earth, Wind and Fire' were among his favorites. An avid "Trekkie", he enjoyed Star Trek episodes, but he also enjoyed watching action-packed movies with his sons; and
