Voting information

Presidential Primaries are right around the corner, please make sure you are registered to vote for the upcoming election. If you are not registered, you can easily register online at: <u>www.443vote.us</u> no later than February 18th. Voting will take place on March 17th at the Oakwood Village Community Center.

Time to be counted!

Expect to receive a form in the mail during March asking for your demographic information. You may also see Census team members going door to door to gather information. This information is vital for our government to ensure we are adequately represented in the House, to secure proper funding according to our population and gather important statistical information. Is your house number displayed?

According to Code: 1372.01 DISPLAY OF ADDRESS SIGNS.

"All main buildings and dwellings used for residential, commercial, and industrial purposes shall include the display of a sign denoting the numerical address of that building or dwelling. Such sign shall be constructed and located in such a fashion as to be visible and readable from the front lot line as determined by the Building and Zoning Inspector and shall conform to all applicable zoning and building ordinances".

This helps with lot identification, deliveries, first responders and the postal service.

Oakwood Village Early Notification Program!

The Oakwood Village Police Department (OVPD) Early Notification Program was developed in response the Ohio House Bill 115 to provide First Responders with information to assist calls involving individuals with communication disabilities. When responding officers are made aware of residents with communication disabilities prior to arrival, they are better equipped to understand and respond appropriately to the situation. The main purpose of the program is to provide a mechanism for residents with communication disabilities to register their specific information with the OVPD. Any and all confidential information provided during the registration process will only be used for First Responder purposes.

The following list represents those individuals who could potentially benefit from this program. It is not intended to be all-inclusive, as each request will be evaluated on a case by case basis.

Autism	Alzheimer's/Dementia	Down's Syndrome
Deaf/Hard of Hearing	Developmental Disability	Mental Illness
Physical Disabilities	Visually Impaired	

The Oakwood Village Early Notification Program allows caregivers or residents with communication disabilities to provide information to police, fire and EMS personnel to be kept in a confidential database maintained by our dispatch center.

Any Oakwood Village caregiver or resident with communication disabilities mentioned above is eligible to register by completing the <u>OVPD Early Notification Form</u>. The resident must currently be or have previously been treated, for the condition to qualify for the program. Persons wishing to be registered but are unable to do so based on their specific condition, may be registered by a legal guardian or court appointed caregiver. Parents may also register their children if they share a residence. Visit <u>https://www.oakwoodpolice.org/</u> to download the form.

The Village of Oakwood has partnered with ReadyNotify through Cuyahoga County in offering the CodeRed emergency notification system to its residents and businesses. *Please update your information* by going to <u>https://www.oakwoodvillageoh.com/</u> and scroll to CodeRed. This service is FREE to all residents and businesses.

CodeRED is a fast communication service allowing Village of Oakwood officials to notify residents of an emergency or weather-related situation.

It is that time of year again where most of us long for the arrival of spring and begin planning for outdoor activities. The first time we can see our lawns and grass in the local parks is when we see the unsightly reminder of what we have been neglecting all winter. The little brown blossoms that are our pet's waste litter the landscape and need proper disposal. The springtime thaw period is a stressful time for stream ecosystems with low oxygen caused by decomposing

organic matter and from all the salt applied to the roadways during the winter and this is exacerbated by our pet's waste.
