WHEREAS, Leonard entered the military and served in the Third Infantry Division, Special Services, in Wurzburg, Germany. He went on to study at Gibbs Junior College, achieving an Associate degree and received his Bachelor of Science from Central State University and his Master of Arts from Cleveland State University in Administration and Supervision; and

WHEREAS, he married Micheline C. Jackson and from the union they had two daughters: Lynnette Michelle and Cheryl Yvette. Leonard was his daughters' biggest fan as he encouraged and applauded their academic and professional successes; and

WHEREAS, as an educator, he began his life's work in 1970 at Patrick Henry Junior High School as a physical education teacher and coach, then in 1975 as Head Baseball and Assistant Basketball Coach at Glenville High School and in 1979 as Head Basketball Coach at West Technical High School. These appointments prepared him for his role as "The Commissioner" of Interscholastic Athletics and Student Activities over 30 years. During his tenure, he directed, supervised and coordinated 16 sports in senior high schools and seven sports in K-8 with a \$4.25 million budget. He brought a more equitable procedure in hiring officials in district athletic contests, upgrading athletic facilities, and brought his interest in minority representation, guidance and support to district administrators; and






