SECTION 2. The Clerk is hereby authorized to present a copy of this resolution to Ayanna Akins.

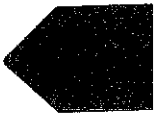

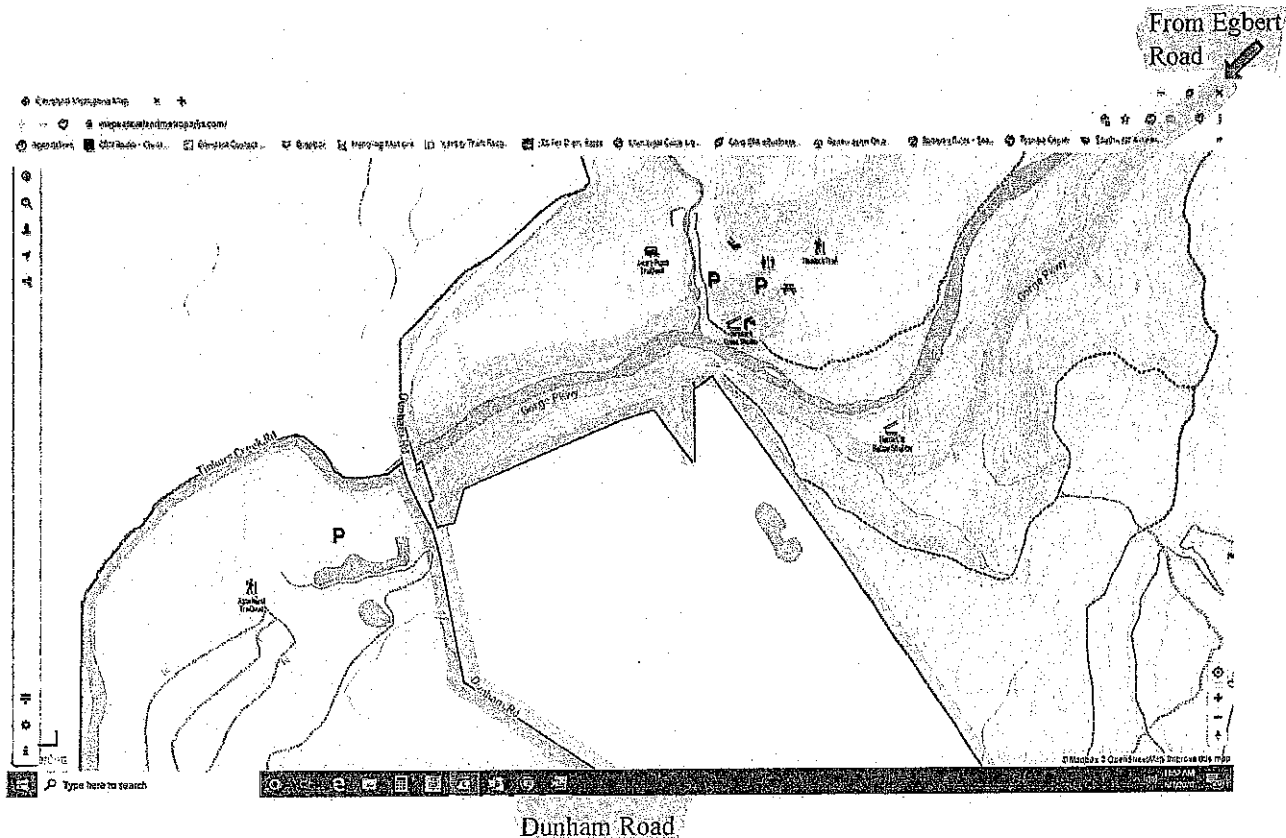
