## **RESOLUTION NO.: 2020-75**

## INTRODUCED BY MAYOR AND COUNCIL AS A WHOLE

A RESOLUTION AUTHORIZING THE MAYOR TO ENTER INTO A COOPERATIIVE AGREEMENT WITH THE CITY OF BEDFORD FOR THE RESURFACING OF FORBES ROAD FROM BROADWAY AVENUE TO NORTHFIELD ROAD IN THE CITY OF BEDFORD AND THE VILLAGE OF OAKWOOD AND DECLARING AN EMERGENCY.

**WHEREAS**, the Service Director and the Village Engineer have advised the Mayor that Forbes Road from Broadway Avenue to Northfield Road is in need of resurfacing; and

**WHEREAS,** the City of Bedford has entered into a contract with Burton Scot Contractors to conduct resurfacing operations in the City of Bedford on Forbes Road between Northfield Road and Broadway Avenue; and

**WHEREAS,** the City of Bedford and Burton Scot Contractors have agreed to conduct additional resurfacing operations in the Village of Oakwood on Forbes Road between Northfield Road and Broadway Avenue at contract cost and per the terms of the Cooperative Agreement attached herein as "Exhibit 1"; and

**WHEREAS**, the Service Director and the Village Engineer have advised the Mayor that resurfacing Forbes Road from Broadway Avenue to Northfield Road in the Village of Oakwood per the terms of the Cooperative Agreement is a cost effective option that will save the Village redundant soft costs including but not limited to engineering design, preparation of plans and specifications, advertising for bids, contract administration and hard costs including, but not limited to bonding and maintenance of traffic.

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio that:

- <u>Section 1</u>. The Mayor is hereby authorized and directed to enter into a Cooperative Agreement with the City of Bedford for the resurfacing of Forbes Road from Broadway Avenue to Northfield Road in the Village of Oakwood.
- Section 2. Council hereby authorizes the expenditure of an aggregate amount not to exceed Fifty Thousand Dollars (\$50,000.00) for the resurfacing of Forbes Road from Broadway Avenue to Northfield Road as provided in Section 1 hereof. The Director of Finance be and is hereby authorized and directed to issue vouchers in the amounts and for the purposes as expressed in Section 1 hereof upon submission of invoices from the City of Bedford and as approved by the Village Engineer, said amounts to be charged to the Street Construction Maintenance and Repair Fund.
- Section 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village, the reason for the emergency being that the City of Bedford plans to immediately begin resurfacing operations, therefore, provided it receives two-thirds (2/3) of the vote of all members of Council elected thereto, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
