A RESOLUTION OF CONDOLENCES TO THE FAMILY OF AUGUSTUS HAWKINS SR.



WHEREAS; August Hawkins Sr. transitioned from this life into the next October 27, 2020 at the age of 77; and

WHEREAS, he was born November 2, 1942 in Tuscaloosa, Alabama to the late Rosa Lee Hawkins and was affectionately known simply as "Gus"; and

WHEREAS, after joining the United States Army and serving his country with courage and excellence as an Army Medic in Vietnam, he was honorably discharged in 1969; and

WHEREAS, while in Vietnam, he taught himself to play the flute. He went onto play the alto, soprano, tenor and baritone saxophone and the keyboard. Also, a phenomenal artist, he enjoyed drawing sketches of people, nature, and the universe; and

WHEREAS, joining the Dynamic Sounds musical group in the 1960's catapulted him into the music industry as the band's manager. In addition, he was their saxophonist and flutist. He was known as "the heart and soul of the group" and played a significant role in facilitating their first record deal as the new S.O.U.L (Sounds of Unity and Love). They played at the Apollo and with such greats as the Persuaders, Cuba Gooding, the Jackson 5 and Kool and the Gang. S.O.U.L. went on to record two additional albums before disbanding in 1978; and

WHEREAS, Gus returned to his medical training as a full-time phlebotomist where he could precisely and painlessly draw blood from any patient. He was well respected in the field and was able to successfully retire while enjoying the fruits of his labor; and

WHEREAS, this honorable man loved deeply and did everything with excellence and determination. He will be known for his intelligence, sense of humor, giving spirit, dedication, and beautiful smile; and

WHEREAS, his brother, David Hawkins, preceded him in death; and

WHEREAS, Augustus "Gus" Hawkins Sr. will be sorely missed by his loving wife, Brenda; his children, Pamela Augustine, Uraina (Hawkins) Scott, Lonnie Hawkins, Alon Hergenhan and Augustus Hawkins, Jr.; his 17 grandchildren and 10 great-grandchildren, along with a host of cousins, nieces, nephews, friends, family and associations who loved him dearly; and
