#### INTRODUCED BY MAYOR AND COUNCIL AS A WHOLE

**ORDINANCE** DECLARING **IMPROVEMENTS** TO CERTAIN PARCELS AN A PUBLIC PURPOSE, EXEMPTING THE TO THE VILLAGE BE WITHIN IMPROVEMENTS TO SUCH PARCELS FROM REAL PROPERTY TAXATION FOR A PERIOD OF THIRTY YEARS, AUTHORIZING THE MAYOR TO ENTER INTO AN AGREEMENT WITH THE BOARD OF EDUCATION OF THE BEDFORD CITY SCHOOL DISTRICT REGARDING SUCH EXEMPTION, REQUIRING THE OWNERS OF SUCH PARCELS TO MAKE SERVICE PAYMENTS IN LIEU OF TAXES, ESTABLISHING AN URBAN REDEVELOPMENT TAX **INCREMENT** EQUIVALENT FUND FOR THE DEPOSIT OF SUCH SERVICE PAYMENTS PURSUANT CODE SECTIONS 5709.41, 5709.42 AND 5709.43, AND REVISED TO OHIO DECLARING AN EMERGENCY.

WHEREAS, the Village of Oakwood (the "Village") has acquired title to certain parcels of real property located in the Village, more fully described as Permanent Parcel Nos. 795-50-014, 795-50-013, 795-49-010, 795-15-048, 795-50-012, 795-50-011, 795-49-005, 759-49-006 and 795-49-007 (collectively referred to as the "Property"), as shown on Exhibit "A" attached hereto and incorporated herein, for the purpose of urban redevelopment of the Property pursuant to a Development Agreement approved by the Oakwood Village Council in furtherance of the City's policy of urban redevelopment as evidenced by the Village of Oakwood Community Reinvestment Area Housing Survey performed by Chagrin Valley Engineering and dated December 2018 which was approved by the Oakwood Village Council on or about January 19, 2019 in Ordinance No. 2019-09; and

WHEREAS, Interstate-McBee, LLC (the "Owner") is interested in redevelopment of the Property by the construction of a commercial real estate project consisting of buildings and other commercial real estate components consistent with the applicable zoning code, along with related landscaping and improvements, as further described in Exhibit "B" attached hereto and incorporated herein, thereby creating jobs and employment opportunities for the residents of the Village and Cuyahoga County; and

WHEREAS, certain public infrastructure improvements are required in order for Owner to proceed with the development of the Property, which include infrastructure described in more detail on Exhibit "C" attached hereto and incorporated herein (collectively, the "Improvements") which Improvements include improvements to certain portions of the Property; and

WHEREAS, Ohio Revised Code Sections 5709.41, 5709.42 and 5709.43 authorize this Council to declare all of the Improvements (as defined in Ohio Revised Code Section 5709.41)

with respect to real property which has been owned by the Village and thereafter conveyed to a private person to be a public purpose, thereby authorizing the exemption of those Improvements from real property taxation for a period of years and to provide for the making of service payments in lieu of taxes by the owner of such parcel and to establish an urban redevelopment tax increment equivalent fund into which such service payments shall be deposited; and

WHEREAS, the Village has determined that it is necessary and appropriate and in the Village's best interest to provide for service payments in lieu of taxes with respect to the Property pursuant to Ohio Revised Code Section 5709.42 (the "Service Payments") to pay a portion of the costs of the redevelopment of the Property and the Improvements; and

WHEREAS, the Property is located within the boundaries of the Bedford City School District (the "School District"); and the School District has been notified of the City's intent to pass this Ordinance in accordance with Ohio Revised Code Sections 5709.41(C) and 5709.83; and

WHEREAS, the Village and the School District have agreed to enter into a Compensation Agreement substantially in the form attached hereto and incorporated herein as Exhibit "D" (the "Compensation Agreement");

NOW, THEREFORE, BE IT ORDAINED BY THE COUNCIL OF THE VILLAGE OF OAKWOOD, STATE OF OHIO, that:

- Section 1. This Council finds and determines that the Improvements described in Exhibits "B" and "C", to be constructed by the Owner or its designee, are declared to be a public purpose for purposes of Section 5709.41 of the Ohio Revised Code.
- Section 2. The Mayor is hereby authorized to enter into the Compensation Agreement with the Board of Education of the School District in substantially the form attached hereto and incorporated herein as Exhibit "D", with such changes therein as are not adverse to the Village, as evidenced by the Mayor's signature thereon.
- Section 3. Pursuant to and in accordance with the provisions of Section 5709.41 of the Ohio Revised Code, 100% of the Improvements are hereby declared to be a public purpose for a period of thirty (30) years and exempt from taxation for a period of thirty (30) years, commencing with the effective date of this Ordinance and continuing for a period of thirty (30) years (the "TIF Exemption").
- Section 4. As provided in Section 5709.42 of the Ohio Revised Code, the owner or owners of the Property are hereby required to and shall make semi-annual Service Payments to the Cuyahoga County Treasurer (the "County Treasurer") on or before the final dates for payment of real property taxes due and payable with respect to the Improvements. In accordance with Section 5709.42 of the Ohio Revised Code, the County Treasurer is hereby requested to distribute a portion of the Service Payments directly to the School District in the amount provided for in the Compensation Agreement. The remaining Service Payments, when distributed to the Village by the County Treasurer, shall be deposited in the Interstate-McBee Urban Redevelopment Tax Increment Equivalent Fund (the "Fund") established in Section 5

hereof. This Council hereby authorizes the Mayor, the Director of Finance and the Village Law Director and other appropriate officers of the City to provide such information and certifications and to execute and deliver or accept delivery of such instruments as are necessary and incidental to collection of those Service Payments and to make such arrangements as are necessary and proper for payment of those Service Payments.

Section 5. This Council hereby establishes pursuant to and in accordance with the provisions of Section 5709.43 of the Ohio Revised Code, the Fund, into which shall be deposited all of the Service Payments distributed to the Village with respect to the Improvements, by or on behalf of the County Treasurer as provided in Section 5709.42 of the Ohio Revised Code, and hereby provides that the moneys deposited in the Fund shall be paid to the Owner to pay any or all acquisition, construction, installation or financing costs, and any or all other direct and indirect costs of the Project, or to reimburse the Owner for such costs, or retained by the Village in accordance with the Development Agreement previously approved by this Council. The Fund shall remain in existence so long as Service Payments are collected and used for the aforesaid purposes, after which time the Fund shall be dissolved in accordance with Section 5709.43 of the Ohio Revised Code and any moneys remaining therein shall be paid to the Village.

Section 6. Pursuant to Section 5709.41(E) of the Ohio Revised Code, the Clerk of Council is hereby directed to deliver a copy of this Ordinance to the Director of the Development Services Agency of the State of Ohio (the "Director") within fifteen days after its passage. On or before March 31st of each year that the exemption set forth in Section 3 hereof remains in effect, the Mayor or other authorized officer of this Village shall prepare and submit to the Director the status report required under Section 5709.40(I) of the Ohio Revised Code.

Section 7. This Council determines that all formal actions of this Council concerning and relating to the passage of this Ordinance were passed in an open meeting of this Council, and that all deliberations of this Council and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements.

Section 8. This Ordinance is declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the Village, and for the further reason that this Ordinance is required to be immediately effective so that the Village can maximize the amount of Service Payments to be received from the Property and pursue economic development opportunities benefitting the Village and its residents for which time is of the essence; wherefore, this Ordinance shall become immediately effective upon receiving the affirmative vote of two thirds of all members elected to Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.

#### EXHIBIT B

#### Description of the Project

The Owner is proposing to build a series of two (2) buildings, the first being a 200,000 square foot office/warehouse facility (expandable to 300,000 square feet) and the second a 100,000 square foot manufacturing facility both of which are to be located off Oak Leaf Road on property known as Permanent Parcel Nos., 795-50-014, 795-50-013, 795-49-010, 795-15-048; 795-50-012, 795-50-011, 795-49-0005, 795-49-006 and 795-49-007 within the Village's Community Reinvestment Area No. 1.

#### EXHIBIT C

#### **Improvements**

The Project shall include but not be limited to:

- Construction of the buildings upon the Project Site, replacement thereof and repairs thereto;
- The provision of utilities and utility connections to the Project Site including but not limited to storm water drainage/detention/retention improvements and measures, sanitary sewerage, water mains and connections, fire hydrants, gas, telecommunications and all trenching and conduits for public utilities;
- Environmental remediation including but not limited to wetlands mitigation for the Project Site;
- Relocation of a stream running through the Project Site which has been determined by the Army Corps of Engineers to be a regulated waterway;
- Stabilization of the subsoil for building pads and other purposes which geotechnical evaluations have determined to be unstable due to previous fill activities;
- Land acquisition including, but not limited to, the possible purchase of two rezoned properties on North Lane including screening and beautification;
- Demolition, abatement and other rehabilitation expenses related to existing buildings and structures;
- Construction of an access road onto the Project Site from Oak Leaf Road as well as screening and beautification of same;
- Mounding, screening and landscaping of the adjacent Waste Management facility which periodically emits noxious odors and is unsightly;
- Screening of all adjacent properties not otherwise mentioned;
- The maintenance of all screening and landscaping;
- · Permitting and other fees and costs;
- Reconstruction of Fair Oaks Road and Oak Leaf Road to be constructed and paid for by the Village;
- Financing and other carrying costs associated with the Project;
- Professional services and other soft costs associated with the Project including, but not limited to, engineering, legal and consulting services;
- Professional services associated with the establishment and administration of tax increment financing (TIF) arrangements;
- Payments in Lieu of Taxes (PILOTS) and similar arrangements with the Board of Education of the Bedford City School District and/or other public entities associated with the TIF or otherwise;
- Payments to the Board of Education of the Bedford City School District and Oakwood Village for agreeing to development incentives.

#### EXHIBIT D

#### COMPENSATION AGREEMENT

This Compensation Agreement (the "Agreement") is made and entered into as of \_\_\_\_\_\_, 2021, by and between the VILLAGE OF OAKWOOD, OHIO (the "Village"), a municipal corporation organized and existing under the constitution, its Charter, and the laws of the State of Ohio with its principal offices at Oakwood Village Hall, 24800 Broadway, Oakwood Village, Ohio 44146, and the BOARD OF EDUCATION OF THE BEDFORD CITY SCHOOL DISTRICT (the "School District"), a public school district with its principal offices located at 475 Northfield Road, Bedford, OH 44146.

#### WITNESSETH:

WHEREAS, pursuant to Ohio Revised Code Section 5709.41, .42, and .43 (together with related provisions of the Ohio Revised Code, the "TIF Act"), the Village may, among other things, (i) declare the increase in assessed value of real property located in the Village to be a public purpose, thereby exempting such increase from real property taxation for a period of time; (ii) provide for the making of service payments in lieu of taxes by the owners of such real property; and (iii) provide for compensation payments to the affected school districts out of such service payments in lieu of taxes; and

WHEREAS, the Village proposes to establish a tax increment financing district with respect to certain property located on or near Oak Leaf Road in the Village, as more fully described in Exhibit "A" attached hereto and incorporated herein (the "Interstate-McBee Property") including future additions to or extensions of the Interstate-McBee Property, to exempt from real property taxation the Interstate-McBee Property pursuant to Section 5709.41 of the Ohio Revised Code (the "TIF Statute") and to require the owners of parcels included in the Interstate-McBee Property (collectively, "Owners"), to make Service Payments In Lieu of Taxes ("Service Payments") and to use such Service Payments to pay a portion of the cost of certain private and public infrastructure improvements; and

WHEREAS, the Village proposes to enact Ordinance No. \_\_\_\_\_\_ (the "TIF Ordinance") on or after \_\_\_\_\_\_, 2021, and therein (a) declare to be a public purpose the improvement to the Interstate-McBee Property and authorize the execution of certain agreements between the Village and Interstate-McBee, LLC, as the Owner of the Interstate-McBee Property, providing for, among other things, the exemption of the increase in value of the Interstate-McBee Property subsequent to the passage of the TIF Ordinance (each improvement having the meaning as set forth in the TIF Act and collectively referred to herein as the "Improvements") relating to the Interstate-McBee Property consistent with the objectives stated in the TIF Ordinance and the payment of Service Payments with respect to such Improvements, and (b) authorize the execution of this Agreement; and

WHEREAS, the Village and the School District will derive substantial and significant benefits from the Improvements; and

WHEREAS, on \_\_\_\_\_\_\_, 2021, and prior to the passage of the TIF Ordinance, the Board of the School District adopted a resolution granting its approval of this Agreement and the exemption of the real property taxes on the Improvements as provided in the TIF Ordinance and waived any further requirements of the TIF Act and Sections 5709.82 and 5709.83 of the Ohio Revised Code on the condition that the Village execute and deliver this Agreement; and

WHEREAS, the TIF Ordinance provides for a 30-year, 100% exemption from real property taxes with respect to the Improvements on the Interstate-McBee Property (the "TIF Exemption") and for the payment of service payments in lieu of taxes with respect to such Improvements ("Service Payments"); and

WHEREAS, to facilitate the construction of certain public and private improvements to the Interstate-McBee Property and to compensate the School District for a portion of the real property taxes that the School District would have received had the Interstate-McBee Property been improved and not been exempted from taxation, the Village and the School District have determined to enter into this Agreement, which Agreement is in the vital and best interest of the Village and the School District and will improve the health, safety and welfare of the citizens of the Village and the School District;

NOW THEREFORE, in consideration of the promises and covenants contained in this Agreement, the parties agree as follows:

Section 1. <u>School District Approval and Agreement.</u> In consideration of the compensation to be provided to it under this Agreement, the School District hereby approves the TIF Exemption in the amount of up to 100% for up to 30 years, as provided for in the TIF Ordinance, and waives any payment of income tax revenues derived from new employees at the Interstate-McBee Property as provided in Section 5709.82 of the Ohio Revised Code.

#### Section 2. Compensation Payments to School District.

- (a) The parties agree that, as consideration for the School District's agreement in Section 1,
  - (i) commencing with the first (1<sup>st</sup>) collection year in which Service Payments are received by the Cuyahoga County Treasurer (the "Treasurer") with respect to the Interstate-McBee Property, and ending with the tenth (10<sup>th</sup>) collection year in which Service Payments are received by the Treasurer with respect to the Interstate-McBee Property, the Village shall cause the Treasurer to pay semi-annually to the School District, but solely from Service Payments received by the Treasurer, an amount equal to forty percent (40%) of the real property taxes that would have been distributed to the School District but for the TIF Exemption.
  - (ii) commencing with the eleventh (11<sup>th</sup>) collection year in which Service Payments are received by the Treasurer with respect to the Interstate-McBee Property, and ending with the fifteenth (15<sup>th</sup>) collection year in which Service Payments are received by the Treasurer with respect to the Interstate-

McBee Property, the Village shall cause the Treasurer to pay semi-annually to the School District, but solely from Service Payments received by the Treasurer, an amount equal to ten percent (10%) of the real property taxes that would have been distributed to the School District but for the TIF Exemption.

- (iii) Commencing with the sixteenth (16<sup>th</sup>) collection year in which Service Payments are received by the Treasurer with respect to the Interstate-McBee Property and continuing until the TIF Exemption ends, the Village shall cause the Treasurer to pay semi-annually to the School District, but solely from Service Payments received by the Treasurer, an amount equal to one hundred percent (100%) of the amounts, if any, the School District would have received but for the TIF Exemption.
- The payments specified in subsection (a) shall be made only to the extent (b) that the Treasurer actually receives Service Payments in an amount equal to the real property taxes that the School District would have received, but for the TIF Exemption. Amounts received by the School District in accordance with subsection (a) of this Section 2 are collectively referred to herein as "TIF Revenue Payments." In the event that in any year the amount of Service Payments actually received by the Treasurer are not equal to the TIF Revenue Payments to be received under this Section 2, such amounts shall be carried forward and will be payable from amounts received in future years after reimbursement of the School District for the applicable percentage of taxes that the School In the event that the valuation of the District would have received in such future year. Interstate-McBee Property is challenged by an Owner or by the School District and the result of such challenge is an increase or decrease in the assessed valuation of such parcel which increase or decrease is finally determined, either through all appeals or after expiration of any appeal period, in a later collection year, the TIF Revenue Payments due to the School District in the year of such final determination and thereafter shall be increased or decreased to reflect such increased or decreased valuation.
- Section 3. <u>Additional Payments</u>. In addition, the Village shall cause Interstate-McBee to pay to the School District Twelve thousand and 00/100 Dollars (\$12,000.00) per year commencing in the second year in which Interstate-McBee receives tax abatements as provided herein and continuing thereafter for a total of fifteen (15) years of payments.
- Payments to the School District in accordance with law. The payments due under Section 2(a) shall be paid to the School District not later than January 31 of each collection year that the TIF Exemption is in effect, commencing with the calendar year in which the first Service Payments are distributed by the Treasurer. The records of the Village relating to the amount of any TIF Revenue Payment or other payment shall be made available to the School District for audit annually by the treasurer of the School District or by an independent auditor of the School District's choice and at its sole expense.

- Section 5. <u>Sharing of Information</u>. The Village agrees to cooperate to share information with the School District as to its receipt of Service Payments upon request of the School District, subject to any restrictions imposed by law and shall provide the School District with a copy of information it sends to the State to comply with annual reporting requirements in connection with the exemption under the TIF Ordinance.
- Section 6. <u>Amendment.</u> This Agreement may be amended or modified by the parties only in writing, signed by both parties to the Agreement.
- Section 7. Entire Agreement, Waiver of Notice. This Agreement sets forth the entire agreement and understanding between the parties as to the subject matter hereof and merges and supersedes all prior discussions, agreements, and undertakings of every kind and nature between the parties with respect to the subject matter of this Agreement. The School District hereby waives any notice requirements set forth in the TIF Act or in Sections 5709.82, 5709.83 and 5715.27(D) of the Ohio Revised Code with respect to the TIF Exemption and waives any defects or irregularities relating to the TIF Exemption.
- Section 8. Notices. All payments, certificates and notices which are required to or may be given pursuant to the provisions of this Agreement shall be sent by the United States ordinary mail, postage prepaid, and shall be deemed to have been given or delivered when so mailed to the address set forth in the first paragraph of this Agreement, to the attention of the Mayor or the Superintendent, as applicable. Either party may change its address for receiving notices and reports by giving written notice of such change to the other party.
- Section 9. <u>Severability of Provisions.</u> The invalidity of any provision of this Agreement shall not affect the other provisions of this Agreement, and this Agreement shall be construed in all respects as if any invalid portions were omitted.
- Section 10. <u>Counterparts.</u> This Agreement may be executed in any number of counterparts, all of which taken together shall constitute one and the same instrument, and any party to this Agreement may execute this Agreement by signing any such counterpart.

AN ORDINANCE DECLARING IMPROVEMENTS TO CERTAIN PARCELS OF REAL PROPERTY TO BE A PUBLIC PURPOSE, DESCRIBING THE PUBLIC INFRASTRUCTURE IMPROVEMENTS TO BE MADE TO BENEFIT THOSE PARCELS REQUIRING THE OWNERS OF THE IMPROVEMENTS THEREON TO MAKE SERVICE PAYMENTS IN LIEU OF TAXES, ESTABLISHING THE OHIO CAT MUNICIPAL PUBLIC IMPROVEMENT TAX INCREMENT EQUIVALENT FUND FOR THE DEPOSIT OF SUCH SERVICE PAYMENTS AND DECLARING AN EMERGENCY

WHEREAS, Ohio Revised Code Sections 5709.40(B), 5709.42 and 5709.43 (the "Act") provide that Council of the Village of Oakwood, Ohio may describe Public Infrastructure Improvements ("Public Improvements") to be made which benefit certain parcels, declare Improvements (as defined in Revised Code Section 5709.40(A)) with respect to such parcels of real property located in the Village to be a public purpose thereby exempting those Improvements from real property taxation for a period of time and provide for the making of service payments in lieu of taxes by the owners of such Improvements, and establish a municipal public improvement tax increment equivalent fund into which such service payments shall be deposited; and

- **WHEREAS**, the Public Improvements are generally described in Exhibit A hereto, and will directly benefit certain parcels of real property located within the Village; and
- WHEREAS, the Village wishes to declare one hundred percent (100%) of the Improvements, as defined by Section 5709.40(A) of the Revised Code, to be a public purpose, thereby wholly exempting the Improvements from real property taxation; and
- **WHEREAS**, the Village has determined that it is necessary and appropriate and in the best interests of the Village to provide for service payments in lieu of taxes pursuant to Section 5709.42 of the Ohio Revised Code; and
- WHEREAS, the Public Improvements will directly benefit several parcels of real property (the "Properties"), the Permanent Parcels of which are listed in Exhibit B attached hereto and incorporated by reference herein, located in the Village; and
- **WHEREAS**, notice of the above described property tax exemptions has been transmitted to the Board of Education of the Bedford City School District (the "School District") pursuant to Ohio Revised Code Sections 5709.40 and 5709.83:
- **NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio, that:
- **SECTION 1**. The Public Improvements described in Exhibit A hereto and anticipated to be made by the Village are hereby designated Public Improvements that directly benefit or, that once made, will directly benefit the Properties which are set forth in Exhibit B hereto and incorporated herein.

SECTION 2. Pursuant to and in accordance with the provisions of Ohio Revised Code Section 5709.40(B), Council hereby finds and determines that one hundred percent (100%) of the increase in the assessed value of the Properties that would first appear on the tax list and duplicate of real and public utility property after the effective date of this Ordinance (which increase in assessed value is herein referred to as the "Improvement" as defined in Section 5709.40(A)) is a public purpose, and one hundred percent (100%) of said Improvement is hereby declared to be a public purpose for a period of thirty (30) years and exempt from taxation commencing with the tax year in which an Improvement first appears on the tax list and duplicate of real and public utility property and that begins after the effective date of this Ordinance and ending on the earlier of (1) the date the Improvement has been exempted from taxation for a period of thirty (30) years or (2) the date on which the Village has collected into the Fund established in Section 4 hereof a total amount sufficient to pay those costs of the Public Improvements authorized in Section 4 hereof which are to be paid from that Fund.

SECTION 3. As provided in Section 5709.42 of the Revised Code, the Owners of the Improvement are hereby required to, and shall make, Service Payments in lieu of taxes to the Cuyahoga County Treasurer semiannually, on or before the date on which real property taxes would otherwise be due and payable for the Improvement. In accordance with Section 5709.42 of the Revised Code, the Cuyahoga County Treasurer shall distribute a portion of the Service Payments directly to the School District in an amount equal to the property tax payments the School District would have received had the Improvement not been exempted under this Ordinance. The Service Payments when distributed to the Village by the Cuyahoga County Treasurer shall be deposited in the Ohio CAT Municipal Public Improvement Tax Increment Equivalent Fund created by Section 4 hereof. Council hereby authorizes and directs the Mayor, Finance Director, Law Director and other appropriate officers of the Village to provide such information and certifications, to sign and deliver any necessary property tax exemption applications and execute and deliver or accept delivery of such instruments as are necessary and incidental to obtaining the exemptions and to make such arrangements as are necessary and proper for payment of said service payments in lieu of taxes.

SECTION 4. Council hereby establishes pursuant to and in accordance with the provisions of Section 5709.43 of the Ohio Revised Code, the Ohio CAT Municipal Public Improvement Tax Increment Equivalent Fund (the "Fund"), into which shall be deposited all of the Service Payments in lieu of taxes distributed to the Village with respect to the Improvement on the Properties or on behalf of the Cuyahoga County Treasurer as provided in Section 5709.42 of the Ohio Revised Code and hereby provides that all of the moneys deposited in the Fund shall be used solely for the following purposes:

- (i) To pay any and all direct and indirect costs of the Public Improvements, including to reimburse the Village for any such costs incurred; and
- (ii) To pay the interest on and principal of bonds or notes, including refunding bonds or notes or other loans issued by the Village to finance those costs of the Public Improvements provided in clause (i) above until such notes or bonds are paid in full.

The Fund shall remain in existence so long as such Service Payments are collected and used for the aforesaid purposes, after which said Fund shall be dissolved in accordance with said Section 5709.43.

SECTION 5. Pursuant to Section 5709.40 of the Ohio Revised Code, the Clerk of the Council is hereby directed to deliver a copy of this Ordinance to the Director of the Department of Development of the State of Ohio within fifteen (15) days after its passage. On or before March 31 of each year that the exemption set forth in Section 2 hereof remains in effect, the Finance Director or other authorized officer of this Village shall prepare and submit to the Director of the Department of Development of the State of Ohio the status report required under Section 5709.40 of the Ohio Revised Code.

**SECTION 6.** Pursuant to Charter Sections 7.13 and 7.14, the Clerk of Council shall post copies of this Ordinance in the Council Chamber and in the five public places as provided by the Codified Ordinances of the Village.

**SECTION 7.** This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village, the reason for the emergency being the immediate necessity of providing funding for the Public Improvements so that such Public Improvements can be constructed, therefore, provided it receives two-thirds (66.67 %) of the vote of all members of Council elected thereto, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.

**WHEREAS,** The Mayor, as Housing Officer, certifies that the improvement to the commercial property in Oakwood Community Reinvestment Area No. 1 owned 7255 Free Avenue Holding, LLC (hereinafter 7255 Free Avenue) qualifies for real property tax exemption under Ordinance 1991-72 as amended by Ordinances 1996-61, 2001-22 and 2019-09; and

WHEREAS, Council must determine the period of such exemption; and

<u>WHEREAS.</u> 7255 Free Avenue intends to reroof, renovate the interior, repave the parking lots & improve the landscaping of its two existing buildings on 7255 Free Avenue at an estimated cost of \$450,000; and

WHEREAS, 7255 Free Avenue's tenant, Schill Landscaping & Lawn Care Service, Inc. has been a top landscaping and rapid snow and ice clearing company for over 20 years exclusively servicing commercial properties in Northern Ohio from downtown Cleveland and its suburbs to Akron and Canton and west to Sandusky and the Lake Erie shore communities, and

**WHEREAS**, within three years, 7255 Free Avenue anticipates sales of \$6.5 Million from its Oakwood site along with approximately 65 employees and an annual payroll of about \$1.9 Million.

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Oakwood, County of Cuyahoga and State of Ohio that:

**SECTION 1.** To the extent that the improvements to the real properties located at 7255 Free Avenue, also known as Permanent Parcel Numbers 795-03-045 and 795-05-001, which is within the Village of Oakwood and within Oakwood Community Reinvestment Area No. 1, and owned by 7255 Free Avenue or its successor(s) in interest, increase the market value of the real property improvements, such amount shall be and hereby is, exempt from real property taxation pursuant to Ordinance 1991-72, as amended by Ordinances 1996-61, 2001-22 and 2019-09, and Section 3735.67(D)(3) of the Ohio Revised Code for a period of fifteen (15) years, beginning in the year following the calendar year of certification of the above to the County Auditor by the Village Housing Officer after the completion of each building. Said exemption shall cover forty nine percent (49%) of the dollar amount by which the improvements increase the market values of the real property improvements. Any additional development on the balance of Permanent Parcel Numbers 795-03-045 and 795-05-001, similar in nature to that presently proposed, will be granted similar incentives provided such development occurs within five (5) years of the adoption of this Ordinance. In addition, all tap-in, permit and review fees as well as the abatement application fee shall be waived for the construction of these facilities and

The period of said exemption shall terminate before the end of fifteen (15) years or at any time after the first year of exemption if the Housing Officer finds and certifies delinquency in a payment of property taxes for the subject property or that the subject property has not been maintained or repaired due to the negligence of the owner.

**SECTION 3.** In the event 7255 Free Avenue or its successor(s) in interest, fail to reconstruct the buildings indicated in its application, which application is attached hereto and expressly made a part hereof by reference and marked Exhibit "A", within eighteen months of the date of this Ordinance this exemption shall become null and void. If 7255 Free Avenue or its successor(s) in interest shall, for any reason, cease operation of the buildings contemplated hereunder, it shall reimburse to the County Auditor for proper distribution an amount equal to 100% of the tax incentive dollars it has saved as a result of this Ordinance to the point operations have ceased.

Pursuant to and in accordance with the provisions of Ohio Revised Code Section 5709.40(B), Council hereby finds and determines that one hundred percent (100%) of the increase in the assessed value of the Properties that would first appear on the tax list and duplicate of real and public utility property after the effective date of this Ordinance (which increase in assessed value is herein referred to as the "Improvement" as defined in Section 5709.40(A)) is a public purpose, and one hundred percent (100%) of said Improvement is hereby declared to be a public purpose for a period of thirty (30) years and exempt from taxation commencing with the tax year in which an Improvement first appears on the tax list and duplicate of real and public utility property and that begins after the effective date of this Ordinance and ending on the earlier of (1) the date the Improvement has been exempted from taxation for a period of thirty (30) years or (2) the date on which the Village has collected into the Fund established in Section 4 hereof a total amount sufficient to pay those costs of the Public Improvements authorized in Section 4 hereof which are to be paid from that Fund.

SECTION 3. As provided in Section 5709.42 of the Revised Code, the Owners of the Improvement are hereby required to, and shall make, Service Payments in lieu of taxes to the Cuyahoga County Treasurer semiannually, on or before the date on which real property taxes would otherwise be due and payable for the Improvement. In accordance with Section 5709.42 of the Revised Code, the Cuyahoga County Treasurer shall distribute a portion of the Service Payments directly to the School District in an amount equal to the property tax payments the School District would have received had the Improvement not been exempted under this Ordinance. The Service Payments when distributed to the Village by the Cuyahoga County Treasurer shall be deposited in the 7255 Free Avenue Holding, LLC Municipal Public Improvement Tax Increment Equivalent Fund created by Section 4 hereof. Council hereby authorizes and directs the Mayor, Finance Director, Law Director and other appropriate officers of the Village to provide such information and certifications, to sign and deliver any necessary property tax exemption applications and execute and deliver or accept delivery of such instruments as are necessary and incidental to obtaining the exemptions and to make such arrangements as are necessary and proper for payment of said service payments in lieu of taxes.

<u>SECTION 4</u>. Council hereby establishes pursuant to and in accordance with the provisions of Section 5709.43 of the Ohio Revised Code, the 7255 Free Avenue Holding, LLC Municipal Public Improvement Tax Increment Equivalent Fund (the "Fund"), into which shall be deposited all of the Service Payments in lieu of taxes distributed to the Village with respect to the Improvement on the Properties or on behalf of the Cuyahoga County Treasurer as provided in Section 5709.42 of the Ohio Revised Code and hereby provides that all of the moneys deposited in the Fund shall be used solely for the following purposes:

- (i) To pay any and all direct and indirect costs of the Public Improvements, including to reimburse the Village for any such costs incurred; and
- (ii) To pay the interest on and principal of bonds or notes, including refunding bonds or notes or other loans issued by the Village to finance those costs of the Public Improvements provided in clause (i) above until such notes or bonds are paid in full.

The Fund shall remain in existence so long as such Service Payments are collected and used for the aforesaid purposes, after which said Fund shall be dissolved in accordance with said Section 5709.43.

SECTION 5. Pursuant to Section 5709.40 of the Ohio Revised Code, the Clerk of the Council is hereby directed to deliver a copy of this Ordinance to the Director of the Department of Development of the State of Ohio within fifteen (15) days after its passage. On or before March 31 of each year that the exemption set forth in Section 2 hereof remains in effect, the Finance Director or other authorized officer of this Village shall prepare and submit to the Director of the Department of Development of the State of Ohio the status report required under Section 5709.40 of the Ohio Revised Code.

**SECTION 6.** Copies of this Ordinance shall be posted as required by the Village Charter.

**SECTION 7.** This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village, the reason for the emergency being the immediate necessity of providing funding for the Public Improvements so that such Public Improvements can be constructed, therefore, provided it receives two-thirds (66.67 %) of the vote of all members of Council elected thereto, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.

# AN ORDINANCE AUTHORIZING THE ESTABLISHMENT OF AN EXTERIOR HOME REPAIR ASSISTANCE PROGRAM FOR SINGLE FAMILY PROPERTIES LOCATED IN THE VILLAGE.

WHEREAS, it is the finding of the Mayor and Council, based upon a variety of information and factors including a Housing Study performed by Chagrin Valley Engineering dated December 2018 and significant economic development planned for the Village, that it would be beneficial to the residents of the Village to provide incentives and assistance to owners of single-family housing units within the Village in performing exterior repairs and maintenance to their properties; and,

**WHEREAS,** the Village has successfully implemented an Exterior Home Repair Assistance Program in Ordinance No. 2019-22 for residents of Ward 4;

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio that:

<u>SECTION 1</u>: The Mayor and Council hereby authorize the establishment of the Oakwood Exterior Home Repair Program (hereinafter "the Program") for the years 2024 through and including 2028 to be administered by the Mayor or his authorized designee.

SECTION 2: Participants eligible for the Program shall be owners of single family residences located in all Wards of the Village other than Ward 4 who shall submit applications on forms developed by the Administrator for reimbursement of 75 % of qualifying expenses for exterior upgrades or repairs up to a total reimbursement of \$3,000.00 (75% of total project costs of \$4,000.00) for owner-occupied properties and 50% of qualifying expenses for exterior upgrades or repairs up to a total reimbursement of \$2,000.00 (50% of total project costs of \$4,000.00) for nonowner-occupied properties. Participation shall be limited to a total yearly expenditure of \$80,000.00 for the years 2024 through 2028. All applications and expenditures shall be subject to approval by Council. Further criteria are set forth in Exhibit "A" attached hereto.

SECTION 3: Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 2 hereof and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the Village. The Director of Finance is hereby further authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 2 hereof and is further directed to issue vouchers of the Village in the amounts and for the purposes expressed in Section 2 hereof, said amounts to be charged to the appropriately designated Fund.

SECTION 4: This ordinance shall take effect at the earliest time allowed by law.

#### OAKWOOD EXTERIOR HOME REPAIR PROGRAM

## **Purpose**

To maintain and improve the physical condition and aesthetics of single-family properties located in the Village thereby benefitting the entire Village.

# **Program Summary**

- Participants eligible for the program shall be owners of single-family residences in the Village with the exception of Ward 4 which has already benefitted from an exterior home repair program approved in Ordinance No. 2019-22. Owners shall submit applications on forms developed by the Program Administrator.
- Participants may be eligible for reimbursement of 75 % of qualifying expenses for exterior upgrades or repairs up to a total reimbursement of \$3,000.00 (75% of total project costs of \$4,000.00) for owner-occupied properties or 50% of qualifying expenses for exterior upgrades or repairs up to a total reimbursement of \$2,000.00 (50% of total project costs of \$4,000.00) for nonowner-occupied properties.
- Participation shall be limited to a total yearly expenditure of \$80,000.00 for the years 2024 through 2028.
- Eligibility is limited to one (1) award per address during the term of the program.
- All work must be performed by qualified contractors who are licensed, bonded, insured and registered with the Village of Oakwood.
- Any applications not acted upon by Council because authorized funding has been committed for the year will be carried over to the following year unless withdrawn by the applicant.
- All applications and expenditures shall be subject to approval by Council.

#### **Eligible Repairs and Improvements**

Eligible projects may include exterior improvements such as roof repairs, siding replacement, siding repairs and/or painting, window replacements, installation or repair of driveways, new shutters, gutters and downspouts, pruning or removal of nuisance trees, etc. Improvements must comply with all applicable planning, zoning, building and other code regulations including all inspections and payment of any associated permit fees.

#### Reimbursement

Property owners are eligible for reimbursements as outlined above after submitting an application to the Program Administrator or his designee, an inspection of the improvements by the Chief Building Official or his designee, proof that all contractors and suppliers have been paid in full for services and materials provided for the project and Council approval.

WHEREAS, Council has determined that economic circumstances and other developments within the Village have necessitated modifications to the Exterior Home Repair Assistance Program for residents of Ward 4 established in Ordinance 2019-22;

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio that:

SECTION 1: That Ordinance 2019-22 which presently reads as follows:

<u>SECTION 1:</u> The Mayor and Council hereby authorize the establishment of the Ward 4 Exterior Home Repair Program (hereinafter "the Program") for the years 2019 through and including 2023 to be administered by the Mayor or his authorized designee.

SECTION 2: Participants eligible for the Program shall be owners of single family residences in Ward 4 who shall submit applications on forms developed by the Administrator for reimbursement of 75% of qualifying expenses for exterior upgrades or repairs up to a total reimbursement of \$3,000.00 (75% of total project costs of \$4,000.00) for owner-occupied properties. Participation shall be limited to a total yearly expenditure of \$80,000.00 for the year 2019 and total yearly expenditures of \$148,750.00 for the years 2020 through 2023 from line item 101.7799.57161. All applications and expenditures shall be subject to approval by Council. Further criteria are set forth in Exhibit "A" attached hereto.

SECTION 3: Council hereby appropriates sufficient funds to effectuate the provisions contained in Section 2 hereof and the Director of Finance is hereby authorized to transfer the funds necessary to complete this expenditure from the available funds of the Village. The Director of Finance be and is hereby further

authorized to issue the fiscal officer's certificate necessary to make the expenditures as described in Section 2 hereof and is further directed to issue vouchers of the Village in the amounts and for the purposes expressed in Section 2 hereof, said amounts to be charged to the appropriately designated Fund.

#### WARD 4 EXTERIOR HOME REPAIR PROGRAM

#### **Purpose**

To maintain and improve the physical condition and aesthetics of single family properties located in Ward 4 of the Village in which significant economic development is planned thereby benefitting the entire Village.

#### **Program Summary**

- Participants eligible for the program shall be owners of single-family residences in Ward 4 who shall submit applications on forms developed by the Program Administrator.
- Participants may be eligible for reimbursement of 75 % of qualifying expenses for exterior upgrades or repairs up to a total reimbursement of \$3,000.00 (75% of total project costs of \$4,000.00) for owner-occupied properties.
- Participation shall be limited to a total yearly expenditure of \$80,000.00 for the years 2022 through 2025.
- Eligibility is limited to one (1) award per address during the term of the program.
- All work must be performed by qualified contractors who are licensed, bonded, insured & registered with the Village of Oakwood.
- Any applications not acted upon by Council because authorized funding has been committed for the year will be carried over to the following year unless withdrawn by the applicant.
- All applications and expenditures shall be subject to approval by Council.

#### **Eligible Repairs and Improvements**

Eligible projects may include exterior improvements such as roof repairs, siding replacement, siding repairs and/or painting, window replacements, installation or repair of driveways, new shutters, gutters and downspouts, pruning or removal of nuisance trees, etc. Improvements must comply with all applicable planning, zoning, building and other code regulations including all inspections and payment of any associated permit fees.

#### Reimbursement

Property owners are eligible for reimbursements as outlined above after submitting an application to the Program Administrator or his designee, an inspection of the improvements by the Chief Building Official or his designee, proof that all contractors and suppliers have been paid in full for services and materials provided for the project and Council approval.

  - (2) 2nd Class First twelve months of continuous service after serving as a 3<sup>rd</sup> Class Patrol Officer.
  - (3) 1st Class All service as a Patrolman after service as a 2nd Class Patrol Officer.

Pledge of Allegiance was recited, and attendance taken.

Motion to approve minutes of May 11, 2021 Council meeting made by Rogers seconded by Sanders.

7 YES: Gaither, Callender, Hardin, Sanders, Rogers, Williams Motion passed.

#### Correspondence

**Clerk**: The Shred Day went very well. We had 102 vehicles come through, six volunteers helping, and we filled the truck <sup>3</sup>/<sub>4</sub> full. You should have received your June calendar which lists my vacation from June 5-14. You were sent the Ohio Collaborative Law Enforcement Agency Certification which I am sure the Police Chief will expound on.

#### Departmental Reports

*Service*-**Haba**: Street striping is mostly done. Ms. Sanders had volunteers clean up Ward 3. Ms. Williams was also there to assist. **Sanders**: Thank you for your help in coordinating that effort.

Building-Marinucci: In the last two weeks we sent out a lot of letters on violations. We are following up on those. The Point of Sales (POS) were sent to Council. You will get another update next month. Several Councilmembers stated they did not receive the POS report. Marinucci: I sent it to the Clerk and every email address I have. I will reissue it tomorrow and make sure you get it. I thought everyone had it.

#### Empire Tree Issue

Rogers: Is there anything new on the Empire Tree situation? Marinucci: It went to Planning. The only issue is screening. It was tabled because Ed Hren has four requirements. I spoke with Dave Hegedus who said he will remove the pipe, backfill behind the block fencing, and restore and be in compliance with our fence ordinance. That all goes to Ed Hren. We are waiting for the confirmation from the adjacent landowners. Rogers: Is there a time frame? Haba interjected, that pipe was removed 1.5 weeks ago. The one neighbor is comfortable with that. Rogers: Is there a timeframe? Marinucci: Ed Hren has to confirm the work. Rogers asked the Law Director. Climer: Ed indicated to me today the Empire owner is cooperative, and the pipe was removed which was confirmed by the one property owner. I understand he will remediate the property. I believe it is anticipated this process will be completed promptly. Marinucci: I believe he wants this quickly completed. Climer: I will speak with Ed on a timeframe. Rogers: Thank you. Williams: There is a piece of property with a boat sitting

there for over 10 years. What are our next steps? **Marinucci**: This goes back to Crystal. I read your email. I believe that is vacant property. That property is to be condemned. I understand there is trash there as well. Robert viewed the property today. There is a car on the property, and I asked him to get the license number. **Williams**: The car belongs to the people across the street. **Marinucci**: I was not aware of that. We have to determine the owner of the property. **Williams**: Do we have ordinances addressing boats? **Marinucci**: Yes. We will follow up on that. One issue is the court system. We filed in court about the red mulch in Ward 1 in December. We are now in June. It is in the court system. I met with Attorney Cirincione. It is difficult to get the owner to remove the mulch. This is moving slower than we would like.

#### LED lighting

**Rogers**: Are there regulations on LED lighting? **Marinucci**: It is permitted. Directional is part of the ordinance. **Rogers**: Someone on the Planning Commission told me they have been asking about it. **Marinucci**: LED is good because it uses less energy. It is brighter.

Police-Garratt: The email you received from Debbie is our final certification from the Ohio Collaborative. The audit was complete, and we received all five certificates. It is extensive. The Citizens Academy will take place September 1-October 20, 2021 Wednesdays from 6:30-8:30 pm. Priority will be residents of the Village then, those who work here. Applications are available at <a href="www.oakwoodpolice.org">www.oakwoodpolice.org</a> or in Village Hall. We have a lot of flyers about phone scams. IRS, SSA scams, identity theft and what to do if your identity is stollen.

Rogers: I called you a while ago, but I didn't get a call back. Garratt: I always call back, but I was out of the office last week. I am sorry. Rogers: I have caller ID. The person on the other line asked if I received my newest social security card. I hung up. I confirmed the phone number, and it was one number off from a business in Oakwood. Garratt: They are sophisticated. The number will come up as a 440, 216 or 330 so you think it is legitimate. Those are ghost numbers. They are very hard to trace. The Federal Trade Commission handles those. It doesn't mean the call is local. I got a scam call from my phone number on my phone. It is ridiculous. If you send out a newsletter, please include information about these scams. The IRS and SSA will never contact you by phone. I am sorry I missed that call; I always try to get back.

### Police Dept. Composition.

Williams asked about the Police Dept. composition. We want to get a cost comparing the auxiliary and the police for the fulltime officers. Garratt: I can do that and include the part-time officers moving to fulltime. By contract when they go to fulltime, they make the exact same rate for 12 months. We cut the Auxiliary budget considerably. Williams: Are Auxiliaries part of the contract? Garratt: No. Williams: We are making a decision to not have Auxiliaries but will go to fulltime. Garratt: Those are two separate budgets. Are you asking me if we decided not to bring back Auxiliaries? Williams: Yes. Garratt: This started with Covid then I was asked to cut further which I did. I haven't ordered any new vehicles this year. We go through two vehicles a year. Even though \$6 of every citation goes toward the police car fund to help pay the lease cost. We cut those and auxiliaries. Williams: Auxiliaries are not being hired back? Garratt: I don't know that. Mayor: I don't need auxiliaries for the concerts coming up. The Auxiliaries are not coming back. Williams: Are we still going through that process? Garratt: We just found out they are not. Williams: The composition states, it consists of a Chief of Police, not to exceed one Captain, not to exceed 3-4 sergeants. Is it 3 or 4? Garratt: It is 4 Sergeants. Williams: Not to exceed 12 fulltime Patrol officers. Is that different that what we had? Garratt: Yes. The current version says 10 Police Officers. I need 12. Williams: It says one Sergeant may be designated by the Mayor As head of the Detective Bureau. Are there criteria for that? Garratt: Sergeants are not in charge of that. We have four shifts with a Sergeant on each one. I need four. The Captain oversees the Detective Bureau. Williams: So, is this part of the contract? Garratt: No that is not. Williams: Is it a conflict to be in this legislation? Garratt: No. There are a lot of things not in the contract which are included in the right to manage

which supersedes the contract. That is stipulated in the contract for an example, shift scheduling. **Williams**: There is no designation for heading the Detective Bureau. **Garratt**: No. **Mayor**: When I first became Mayor there were more Sergeants than Patrol Officers. It was out of control. **Williams**: If Auxiliaries not coming back, how do you select which ones go or stays? **Garratt**: All at-will employees are not governed by the contract. **Williams**: Are there criteria who stays or goes. **Garratt**: It has to do with availability and seniority. **Williams**: In the cost analysis it would include the Auxiliaries pay scale in the budget.

Law-Climer: Intestate McBee legislation is closing in on a resolution. The Planning Commission last night recommended the legislation which Oakwood will approve the purchase and sale of the property as necessary for the TIF. Our Charter reads, in contracts for real estate is first considered by the PC which then makes the recommendation to Council. Because of the time crunches of the construction season, we would like to hold a special meeting Thursday May 27<sup>th</sup>, and if necessary, Tuesday and Wednesday next week. These transfers need to get done so the TIF legislation can be passed which has been on the agenda for months (2021-06).

#### Bugarcic Property and Sea Gulls

**Rogers**: At the last meeting I asked about the seagulls at the Bugarcic property on Macedonia. There was a question regarding the regulation of chickens. **Climer**: The research confirmed he is grandfathered in the number of chickens; however, the additional requirements enact the keeping of chickens can be applied to him. **Rogers**: Did you hear that, Dan? I didn't get anywhere with showing the Building Dept. the pictures of the sea gulls. **Mayor**: Mr. Marinucci is no longer in the meeting. **Hardin**: Can you make sure he gets the information, and something is done? **Mayor**: Yes.

Mayoral Report-Mayor: The Ohio Public Works Commission approved a grant for the Fair Oaks Reconstruction Project which runs north parallel to I-271 with projected costs of \$1.1 million. The grant is ½ million dollars with ½ million-dollar zero-percent loan over 20 years which will begin in 2024 at \$20,000 a year. The \$360,000 balance is for the rehab of Alexander and Fair Oaks with a new traffic signal and radar detection intelligence paid by Premier Development. We will only pay \$25,000 a year over 20 years on the project. Great news!

#### McBee Update

**Mayor** continued: Interstate McBee was awarded the contract with Premier Development for their building. It will be a 200,000 sq. ft. building. It will begin in the fall – one year ahead of schedule. That is why it is important to move on this legislation. It will take time to rehab the land prior to foundation work. Great news!

#### Premier Update

Mayor continued: I sent a rendering of the first building to go up on the Premier site. This is for light manufacturing which will be parallel to the mound, not near I-271. It is a high-tech facility. The largest in Oakwood. Because of the issues at our Mexican border, the green card legal immigrants working on our landscaping haven't been processed in the U.S. They are spending all their time on the illegals. The group which would have cleared up the brush would have done it by now but there are so few landscapers here now. The buildings near the interstate will be mostly glass. Rogers: This is not what was given to us before. Mayor: You aren't going to see this building anyway and the company coming has payroll over \$20 million —three times the size of the largest companies in Oakwood. Rogers: Did you say Premier is putting up McBee's building? Mayor: Yes. Rogers: That worked out well. Mayor: They looked at three different developers and they chose Premier. Premier has more supplies of copper, steel, timber, etc. which has increased substantially. They have a better price because they ordered it before the prices went up. Hardin: Did we get the \$20,000 this year yet? Mayor: We will get it. The agreement states we will get it. Hardin: I spoke with the Law Director about it and he said you would have to contact Premier. Mayor: The contract is clear; Premier owes us \$20,000 in 2021. Hardin: Can we make sure it is put in the contract for a certain date? The Law Director said it is

contingent upon a discussion with the Mayor. Can we make that happen? Climer: The contract does not make the payment contingent upon any discussion with the Mayor: Hardin: Correct. Climer: In 2021 there isn't a specific date. Hardin: Can we include a specific date? Climer: He can negotiate payment by a certain date. Hardin: Thank you. Has there been a groundbreaking date for Premier? Mayor: No. Williams: Is this new for the \$25,000? Mayor: That is in the agreement you approved. Williams: Which deal? Mayor: For the donation.

#### New Companies to Oakwood

Mayor: The next regular meeting will have a 49% Community Reinvestment Agreement and 33.3% TIF for 15 years and the second for 30 years on the next three companies coming to Oakwood. It does not require School Board approval. Schill which is new to the community on Free Avenue will do the landscaping and the corners of Free and Wright Avenue. We already did this for Federal Metal, Caterpillar Ohio, Petitti's, Family Dollar, Sunoco, Community Care Ambulance, Quality Inn and McDonalds. Ohio CAT will be expanding which is Ohio Machinery. Federal Metals is experiencing their third expansion which will be in a few months. I am in discussions with Jobs Ohio and another entity which gives grants. Hardin: Are we approaching businesses. Is this our norm or are they asking for them? Mayor: When they consider expanding, I meet with them to encourage them to expand here in Oakwood. This is money which would have gone to the County but is coming back to us. Williams: We can expect to have to find someone else to move into these places in 30 years, am I correct? Mayor: We haven't lost one company we have given an incentive to, even after the incentive has expired in the 25 years I have been here. Williams: Are any 30 years TIF's? Mayor: The TIFs are relatively new. We are talking about 15 years CRA, that is the big money forgoing property taxes. Williams: So, we haven't seen those which have been put into place. Mayor: The 15 years have expired with many companies here in the Village and they are still here. Williams: We haven't had 30 years expired. Mayor: TIFs have only been done 5-6 years. This is new. Up until now we have been doing Community Reinvestment Agreements as other members of Council will know. I would say <sup>3</sup>/<sub>4</sub> of them have expired yet those companies are still here. Williams: Do we know the trends for 30-year agreements. Mayor: The TIFs are much smaller as in \$1 million they would save \$1,000. You are looking at peanuts. Most communities haven't used TIFs because they don't understand them. This is money that would have gone to the County and is coming back to us. Hilton Inn was given an incentive by the County if they lost money, it would be made up by taxpayer money. They are down \$22 million in the first two years due to Covid. They were paid back \$22 million. The Hampton Inn which is part of the Hilton chain was never part of the incentive package at all. Williams: So, you haven't researched what happens after 30 years. This is new for us? Mayor: As I am saying, TIF's are only 5-10% of what a CRA brings in. Many communities have lost companies, but we have the 4<sup>th</sup> lowest property tax in the County and because we have excellent Safety Forces; both Police and Fire, greenspace which attracts more employees as well as the concerts. That is why they stay in Oakwood. Williams: We have history with 15-year TIFs not 30 years. Mayor: We have history with CRAs. Most communities aren't implementing TIFs because they don't understand them. We use TIF money for road work or landscaping. These three will contain the same language as those we have passed except for the name of the companies and what they do.

#### Summer Programs

**Mayor**: We will begin our Summer Senior Tours starting with a winery tasting with food, and music. We aren't requiring screening and masks, but we are prohibiting the town drunks. Laughter followed.

#### Marshall Sewell Concert Series

**Mayor**: The Chief indicated we are starting a Marshall Sewell Concert Series with four concerts. They will be July 29<sup>th</sup> with LaFlavour, August 5<sup>th</sup> BeeGees Tribute Band, August 12<sup>th</sup> with Mike Albert's Elvis Show, and August 19<sup>th</sup> will be for the first time out of Las Vegas, the son of the legendary Jackie Wilson. His son looks

like him and sounds like him. He will be bringing the group, the Chiclettes, to back him up along with a small orchestra. It will be quite a show.

### Janice Kenney Summer Program

**Mayor**: Also, June 21<sup>st</sup> the Janice Kenney Summer Program will be three weeks long for 8–14-year-old children. He reviewed some of the offerings the third week of July where the enrichment begins for four weeks of which entities in California is looking at.

#### Juneteenth

Williams asked about a Juneteenth celebration on June 19<sup>th</sup> which is the official ending of slavery in the U.S. That is being considered a holiday have we considered an event for this? The state is considering offering it as a legal paid holiday. Mayor: In conjunction with Bobby Wilson being here. Williams: I am talking about June 19<sup>th</sup>. Mayor: I have many business meetings throughout the week. Carlean will be back at the end of the week so we can look into that. Williams: I am not asking you to plan it. We can form a committee. I am sure many people will be interested in being part of it. Mayor: Okay. Gaither: We will talk about June 19<sup>th</sup>.

#### Open Floor Comments

**Donna Edwards**, **6181 Whitetail Run**: I can volunteer for community events. **Mayor**: Give Dee a call and we will take the help. **Edwards**: I am here to talk about my driveway. The snow removal contractor damaged my driveway. I was told the contract is at my own risk. A couple years ago the contractor damaged my driveway. I mentioned this at a meeting at the time. **Haba**: I will look at it but you are correct, we are not responsible for any damage caused by the snow removal. **Edwards**: I just wanted to make sure. Edwards gave him her phone number.
