## ORDINANCE NO. 2021 – 60

## INTRODUCED BY MAYOR AND COUNCIL AS A WHOLE

## AN ORDINANCE APPROVING PREMIUM PAY FOR EMPLOYEES OF THE VILLAGE OF OAKWOOD, TO BE PAID OUT OF THE CORONAVIRUS LOCAL FISCAL RECOVERY FUND CREATED BY H.R. 1319-225 AND AUTHORIZED UNDER OHIO H.B. 168

**WHEREAS**, the Congress of the United States of America passed H.R. 1319, creating the Coronavirus Local Fiscal Recovery Fund; and

WHEREAS, pursuant to H.R. 1319, funds allocated to the Coronavirus Local Fiscal Recovery Fund have been appropriated to make payments to states for distribution by the state to local governments to provide premium pay to workers of local government whose positions are critical to protect the health and well-being of residents of the local government; and,

**WHEREAS**, the Ohio Legislature has passed H.B. 168, authorizing distribution of those funds in accordance with the provisions of H.R. 1319; and

WHEREAS, the Village of Oakwood wishes to provide a one-time premium pay to each of its employees, to include elected officials, who have been critical to the protection of the health and well-being of the residents of the Village of Oakwood as a way to thank them for their continued service during the COVID-19 public health emergency;

**NOW THEREFORE, BE IT ORDAINED** by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio that:

**SECTION 1.** All employees of the Village of Oakwood, including those elected officials, have been, and are therefore designated as, critical to the protection of the health and well-being of the residents of the Village of Oakwood during the COVID-19 public health emergency.

**SECTION 2.** Council hereby authorizes the expenditure of \$500 premium pay to each employee of the Village of Oakwood, to include elected officials, in a total amount not to exceed \$89,000. The premium pay shall be in included in the paycheck immediately following the effective date of this ordinance.

SECTION 3. The Director of Finance be and is hereby authorized and directed to issue payment to employees, to include elected officials, in the amounts and for the purposes as expressed in Section 2 hereof, said amounts to be charged to the Fund No. 250-7799-52360.

**SECTION 4.** This Ordinance is to go into effect at the earliest time permitted by law.
