INTRODUCED BY MAYOR AND COUNCIL AS A WHOLE

**A RESOLUTION OF SUPPORT FOR THE WORK OF THE
CLEVELAND CUYAHOGA COUNTY PORT AUTHORITY
AND DECLARING AN EMERGENCY**

WHEREAS, Lake Erie has always been the area's most vital natural asset and through the Port of Cleveland giving opportunity for the City of Cleveland to prosper on the Great Lakes; and

WHEREAS, The Cleveland-Cuyahoga County Port Authority remains indispensable to the economic success of Cleveland and the other communities in Cuyahoga County, which is why the Village Council supports its work; and

WHEREAS, Council believes that it is critical that the Port continue to operate its programs and support maritime and economic activities taking advantage of the economic opportunities on our Great Lake.


NOW THEREFORE, BE IT RESOLVED by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio that:


SECTION 1. The Village of Oakwood, the Village Council and Mayor strongly support the work of the Port Authority.

SECTION 2. The Clerk of Council is hereby authorized and directed to send a copy of this legislation to Dan Poeck 6985 Walton Road, Walton Hills, OH 44146.

SECTION 3. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village. The reason for the emergency is that this is a critical time for the Port Authority to continue to keep Cuyahoga County's economy afloat. Therefore, provided it receives two-thirds ($\frac{2}{3}$) of the vote of all members of Council elected thereto, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.




