

ORDINANCE NO. 2025-52

INTRODUCED BY MAYOR AND COUNCIL AS A WHOLE

**AN EMERGENCY ORDINANCE AUTHORIZING THE
MAYOR TO ENTER INTO A MASTER COOPERATION
AGREEMENT WITH CUYAHOGA COUNTY TO
PERFORM PAVEMENT PREVENTATIVE
MAINTENANCE SERVICES ON FORBES ROAD**

WHEREAS, the Village and Cuyahoga County have entered into agreements for the construction of certain roadway improvements on Forbes Road where the Village agreed to cooperate with the County and the County agreed to participate in the design and construction of such improvements, and

WHEREAS, the County recognizes the need to protect its financial investment and desires to provide to the Village pavement preventative maintenance services for the roadway improvements referenced above, and

WHEREAS, the Village has recognized that such pavement preventative maintenance services are in the public interest and desire to supplement the original Cooperation Agreement to cooperate with the County in the provision of such services.

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio that:

WHEREAS, the Village Council deems it necessary and in the best interests of the health, safety and welfare of all of the Village residents to perform preventative maintenance on Forbes Road within the Village:

SECTION 1. The Mayor is hereby authorized to enter into the Master Cooperation Agreement for Pavement Preventative Maintenance Services with Cuyahoga County, a copy of which is attached hereto as Exhibit A.

SECTION 2. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety and welfare of the inhabitants of the Village, the reason for the emergency being that the county funds must be utilized for the 2025 construction season, therefore, provided it receives two-thirds (b) of the vote of all members of Council elected thereto, said Ordinance shall be in full force and effect immediately upon its adoption by this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.
