

AMENDING ORDINANCE NO. 2025-48A

INTRODUCED BY MAYOR AND COUNCIL AS A WHOLE

AN ORDINANCE AMENDING ORDINANCE 2025-48A SETTING FORTH CERTAIN POSITIONS OF EMPLOYMENT AND PAY RATES FOR THE VILLAGE OF OAKWOOD FIRE DEPARTMENT AND DECLARING AN EMERGENCY

WHEREAS, it is necessary for Council to review salaries ranges from time to time for employment positions within the Village; and,

WHEREAS, employee compensation shall not exceed the authorized salary ordinance maximum pay range; and,

WHEREAS, the Mayor and Finance Director have represented in writing that funds are available to grant an eight percent (8%) pay raise for members of the Oakwood Fire Department; and,

WHEREAS, Ordinance 2025-48A was passed for the foregoing purposes on July 8, 2025; and,

WHEREAS, it has been discovered that a mathematical error has been discovered resulting in said Ordinance 2025-48A listing a Weekend Differential Pay Rate for Captains of \$44.25 rather than the correct rate of \$42.25;

NOW THEREFORE, BE IT ORDAINED by the Council of the Village of Oakwood, County of Cuyahoga, and State of Ohio that:

SECTION 1. Ordinance 2025-48A which presently reads in pertinent part as follows:


is hereby amended to read as follows and the foregoing provisions are hereby repealed:



SECTION 2. This Ordinance is hereby declared to be an emergency measure necessary for the immediate preservation of the public peace, health, safety, and welfare of the inhabitants of the Village, the reason for the emergency being that the same that relates to the daily operation of a municipal department and the ability of the village to provide uninterrupted services to the citizens of the Village, therefore, provided it receives the two-thirds vote of all members of Council elected thereto, said ordinance shall be in full force and effect immediately upon its adoption by

this Council and approval by the Mayor, otherwise from and after the earliest period allowed by law.




